The best approach to the grounds is Route 495 to 25 and over the Bourne Bridge at Buzzards Bay, follow Route 28 toward Falmouth to, Route 151 East towards Mashpee after approximately 2.5 miles there is a movie theatre on the left. Very shortly thereafter on the left is a softball diamond. The entrance road is immediately before the diamond on the left; you will see a sign for Ranch Rd on the right-hand side. Proceed to the parking area at the end of the road.
